Reference is made to the Company's announcement dated 7 April 2006. The Company made this announcement as per the requirements of the listing approval granted by the Stock Exchange in respect of the New Shares to be issued and allotted upon the conversion of the Debentures. During the month of January 2007, HK\$52,450,000 Debentures were converted and 209,800,000 New Shares were issued pursuant to such conversions. The cumulative amount of the New Shares issued is accounted for 13.39 % of the issued share capital of the Company as disclosed in the Monthly Announcement dated 2 January 2007.

Reference is made to the Company's announcement dated 7 April 2006 (the "Announcement"). The Company made this announcement as per the requirements of the listing approval granted by the Stock Exchange in respect of the New Shares to be issued and allotted upon the conversion of the Debentures.
