Upon effective of the capital reduction on 9 November 2011, the authorised share capital of South Sea Petroleum Holdings Limited (the "Company") be reduced from US\$500,000,000 divided into 1,000,000,000 shares of US\$0.50 each to US\$1,000,000 divided into 1,000,000,000 shares of US\$0.001 each and the nominal value of all the issued and unissued shares in the share capital of the Company from US\$0.50 to US\$0.001 per reduced share. After such reduction, the authorised capital of the Company be increased from US\$1,000,000 (divided into 1,000,000,000 reduced shares of US\$0.001 each) to US\$500,000,000 (divided into 500,000,000,000 reduced shares of US\$0.001 each) by the creation of 499,000,000,000 unissued reduced shares of US\$0.001 each.
