POLL RESULTS OF ANNUAL GENERAL MEETING

The Board is pleased to announce that the Ordinary Resolutions were duly passed by the Shareholders at the AGM held on 3 September 2010 by way of poll.

Reference is made to the circular of China Gamma Group Limited (the “**Company**”) dated 30 July 2010 (the “**Circular**”). Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise stated.

The Board is pleased to announce that the ordinary resolutions as set out in the notice of AGM of the Company dated 30 July 2010 (the “**Ordinary Resolutions**”) were duly passed by the Shareholders at the AGM held on 3 September 2010 by way of poll.

As at the date of the AGM, the number of issued Shares was 2,867,681,490 Shares, which was also the total number of Shares entitling the Shareholders to attend and vote for or against the resolutions. No Shareholder was required to abstain from voting on the Ordinary Resolutions and no Shareholder was entitled to attend and vote only against the Ordinary Resolutions at the AGM.

The Company had appointed Tricor Secretaries Limited, the branch share registrar of the Company in Hong Kong, as scrutineer for the vote-taking at the AGM.
