SUBSCRIPTION OF NEW SHARES

On 20 May 2011 (after trading hours of the Stock Exchange), the Company entered into the Subscription Agreement with the Subscriber pursuant to which the Subscriber has conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue, 60,000,000 Shares at the Subscription Price of HK\$0.5 per Subscription Share.

The Subscription Price of HK\$0.5 per Subscription Share represents: (i) a discount of approximately 9.09% to the closing price of HK\$0.55 per Share as quoted on the Stock Exchange on 20 May 2011, being the closing price on the date of the Subscription Agreement; and (ii) a discount of approximately 8.42% to the average of the closing prices of HK\$0.546 per Share as quoted on the Stock Exchange for the last five consecutive trading days immediately preceding the date of the Subscription Agreement. The Subscription Price was arrived at after arm's length negotiations between the Company and the Subscriber with reference to the liquidity and the recent trading performance of the Shares.

The Directors consider that the Subscription Price and the terms of the Subscription Agreement are fair and reasonable and are in the interests of the Company and the Shareholders as a whole.

The Subscription Shares represent approximately 1.48% of the existing issued share capital of the Company and approximately 1.46% of the issued share capital of the Company as enlarged by the allotment and issue of the Subscription Shares. The net proceeds of the Subscription of approximately HK\$29.8 million will be applied for the Company's investment in small loan and guarantee companies in the PRC.

THE SUBSCRIPTION

To the best of the knowledge, information and belief of the Directors and having made all reasonable enquiries, the Subscriber is an Independent Third Party.

Number of Subscription Shares

Pursuant to the Subscription Agreement, the Company has conditionally agreed to allot and issue and the Subscriber has conditionally agreed to subscribe in cash of HK\$30,000,000 for a total of 60,000,000 Subscription Shares at the Subscription Price of HK\$0.5 per Subscription Share. The 60,000,000 Subscription Shares represent approximately 1.48% of the existing issued share capital of the Company and approximately 1.46% of the issued share capital of the Company as enlarged by the allotment and issue of the Subscription Shares as at the date of this announcement.

Subscription Price

The Subscription Price of HK\$0.5 per Subscription Share represents:

- (i) a discount of approximately 9.09% to the closing price of HK\$0.55 per Share as quoted on the Stock Exchange on 20 May 2011, being the closing price on the date of the Subscription Agreement; and
- (ii) a discount of approximately 8.42% to the average of the closing prices of HK\$0.546 per Share as quoted on the Stock Exchange for the last five consecutive trading days immediately preceding the date of the Subscription Agreement.

The net Subscription Price, after deduction of relevant expenses (including but not limited to legal expenses and disbursements) of approximately HK\$29.8 million, is estimated to be approximately HK\$0.497 per Subscription Share.

The Subscription Price was arrived at after arm's length negotiations between the Company and the Subscriber with reference to the liquidity and the recent trading performance of the Shares. The Directors consider that the Subscription Price and the terms of the Subscription Agreement are fair and reasonable and are in the interests of the Company and the Shareholders as a whole.

Condition of the Subscription

The Subscription is conditional upon the Listing Committee of the Stock Exchange granting or agreeing to grant the listing of, and permission to deal in, the Subscription Shares.

In the event that the condition of the Subscription is not fulfilled on or before 9 June 2011 or such other date as may be agreed between the parties to the Subscription Agreement, the Subscription Agreement shall cease and determine and neither the Company nor the Subscriber shall have any obligations and liabilities under the Subscription Agreement.

Completion of the Subscription

Completion of the Subscription will take place at 4:00 p.m. on the third Business Days after the condition of the Subscription is fulfilled (or such other date as may be agreed between the parties of the Subscription Agreement).

Ranking of the Subscription Shares

The Subscription Shares, when allotted and issued, will rank equally in all respects among themselves and with the Shares in issue on the date of allotment and issue of the Subscription Shares.

Mandate to issue the Subscription Shares

The issue of the Subscription Shares is not subject to Shareholders' approval.

The Subscription Shares will be allotted and issued pursuant to the General Mandate. The maximum number of Shares that can be issued under the General Mandate is 734,956,806 Shares. 370,000,000 Shares have been allotted and issued under the General Mandate pursuant to three subscription agreements dated 29 March 2011. As at the date of this announcement, 364,956,806 Shares under the General Mandate have not yet been utilised. The General Mandate is sufficient for the issue and allotment of the Subscription Shares. The 60,000,000 Subscription Shares constitutes approximately 16.44% of the unused General Mandate.

Application for listing

Application will be made by the Company to the Listing Committee of the Stock Exchange for the listing of, and permission to deal in, the Subscription Shares.

REASONS FOR THE SUBSCRIPTION AGREEMENTS

The Company is an investment holding company and its principal subsidiaries are engaged in the holding of equity or equity-related investments.

In view of recent strong economic growth in the PRC, the Company intends to strengthen its investments in the PRC. The Company has entered into a couple of agreements in this aspect including but not limited to those agreements as disclosed in the announcements of the Company dated 2 December 2010, 24 March 2011, 31 March 2011 and 4 April 2011. The Directors consider that it is in the interest of the Company and its Shareholders as a whole to strengthen its financial position by entering into the Subscription Agreement, which will enable the Company to expand its capital base for future investment opportunities in the PRC in order to achieve long-term capital appreciation of its assets primarily through equity and equity-related investments.

The gross proceeds of the Subscription is HK\$30 million. All the net proceeds of the Subscription of approximately HK\$29.8 million will be applied for the Company's investment in small loan and guarantee companies in the PRC. The Directors consider that the Subscription Agreement is entered into upon normal commercial terms following arm's length negotiations between the Company and the Subscriber and that the terms of the Subscription Agreement are fair and reasonable so far as the interests of the Company and the Shareholders as a whole are concerned. The Directors also consider that the Subscription will strengthen the financial position and shareholder base of the Group.
