## APPOINTMENT OF EXECUTIVE DIRECTOR AND DEPUTY CHAIRMAN

He will hold office until the next annual general meeting of the Company and will retire at that general meeting, but will become eligible for reelection pursuant to the Articles of Association of the Company. He will be entitled to a director's fee to be determined by the Remuneration Committee of the Company with reference to their duties and responsibility in the Company and the market benchmark.

Mr. Wang has confirmed to the Company that he had not held directorship in any other listed companies during the last three years, nor has he previously held any positions with the Company or any of its subsidiaries. He does not have any relationship with any director, senior management or substantial or controlling shareholders of the Company.
