**1. INTRODUCTION**

At the AGM, resolutions will be proposed to i) grant to the Directors general mandate to repurchase Shares; ii) grant to the Directors general mandate to issue Shares; iii) extend general mandate to issue Shares; and iv) re-elect the retiring Directors. In compliance with the Listing Rules, this circular contains the explanatory statement and gives all the information reasonably necessary to enable the Shareholders to make informed decisions on whether to vote for or against the resolutions to be proposed at the AGM.

### **2. GENERAL MANDATE TO REPURCHASE SHARES**

At the annual general meeting of the Company held on 22 December 2006, an ordinary resolution was passed by the then Shareholders granting the existing Repurchase Mandate to the Directors and such mandate will lapse at the conclusion of the AGM.

An ordinary resolution will be proposed at the AGM to grant to the Directors a fresh Repurchase Mandate i.e. a general and unconditional mandate to repurchase Shares subject to the maximum number of Shares of up to 10% of the aggregate nominal amount of the share capital of the Company in issue at the date of passing of such resolution. The fresh Repurchase Mandate will remain in effect until the earliest of (i) the date of the next annual general meeting of the Company; (ii) the date by which the next annual general meeting of the Company is required to be held by any applicable laws of the Cayman Islands or the Listing Rules; and (iii) the date upon which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

### **3. GENERAL MANDATE TO ISSUE SHARES**

At the annual general meeting of the Company held on 22 December 2006, an ordinary resolution was passed by the then Shareholders granting the existing Issue Mandate to the Directors and such mandate will lapse at the conclusion of the AGM.

An ordinary resolution will be proposed at the AGM to grant to the Directors a fresh Issue Mandate i.e. a general and unconditional mandate to allot, issue and deal with, otherwise by way of rights issue or any option scheme or similar arrangements for the time being adopted for the grant or issue to officers and/or employees of the Company and/or any of its subsidiaries of shares or rights to acquire shares in the Company or any shares of the Company issued as scrip dividends pursuant to the memorandum and articles of association of the Company, additional Shares with an aggregate nominal value not exceeding 20% of the aggregate of the total nominal value of the share capital of the Company in issue at the date of the passing of such resolution. The fresh Issue Mandate will remain in effect until the earliest of (i) the date of the next annual general meeting of the Company; (ii) the date by which the next annual general meeting of the Company is required to be held by any applicable laws of the Cayman Islands or the Listing Rules; and (iii) the date upon which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

### **4. EXTEND GENERAL MANDATE TO ISSUE SHARES**

An ordinary resolution will be proposed at the AGM to extend the Issue Mandate by the addition to the aggregate nominal value of the share capital of the Company which may be allotted or agreed conditionally or unconditionally to be allotted by the Directors pursuant to such general mandate of an amount representing the aggregate nominal value of the share capital of the Company repurchased by the Company pursuant to the Repurchase Mandate provided that such extended amount shall not exceed 10% of the aggregate of the total nominal value of the share capital of the Company in issue on the date of passing the resolution approving the Issue Mandate.

### 5. RE-ELECTION OF RETIRING DIRECTORS

*In relation to ordinary resolution number 3 set out in the notice of the AGM regarding the re-election of retiring Directors, Mr. Xiang Song, Mr. Pan Chang Chi and Mr. Cheung Chuen shall retire as Directors by rotation at the AGM pursuant to articles 87(1) and 87(2) of the Articles, and, being eligible, will offer themselves for re-election.*

#### **Mr. Xiang Song**

Mr. Xiang Song (項松), aged 36, is an executive director and the chief executive officer of the Company. Mr. Xiang graduated with a bachelor's degree in mechanical engineering from the University of Science and Technology of Beijing (北京科技大學) in 1993. Prior to joining the Group in July 1998, Mr. Xiang had gained substantial management experience when he served as the plant general manager and engineer of Guangzhou Printronics Circuit Corp. (廣州普林電路公司). He has more than 12 years of management experience in the printed circuit board ("PCB") industry. Mr. Xiang was appointed as an executive Director in September 2000 and he is principally responsible for the supervision of the Group's technology, production and quality control. Save as disclosed above, Mr. Xiang did not hold any directorship in any public listed companies in the last three years and he does not hold any position in the Group.

Mr. Xiang has entered into a service agreement dated 8 May 2007 with the Company for a term of three years commencing from 8 May 2007, with a fixed term of one year, which shall be terminated if either party giving not less than six months' notice in writing to the other after the expiration of the said fixed term of one year. As at the Latest Practicable Date, Mr. Xiang is entitled to a monthly salary of HK\$27,500 which is determined on the prevailing market rate and a year-end bonus to be determined by the Board with reference to the Company's performance and profitability.

As at the Latest Practicable Date, Mr. Xiang has 1,500,000 underlying Shares attached to the share options granted by the Company. Save as disclosed above, Mr. Xiang does not have any other interests in the Shares, underlying Shares and debentures of the Company within the meaning of Part XV of the SFO and he does not have any relationship with any Directors, senior management or substantial or controlling Shareholders.

#### **Mr. Pan Chang Chi**

Mr. Pan Chang Chi (潘昌馳), aged 55, is an independent non-executive director, members of audit committee and remuneration committee of the Company. Mr. Pan has had the experience as a senior economist. He graduated from Xiamen University (廈門大學) in 1998 with a master's degree in law. He has extensive experience in financial management while working as a senior economist in the Fuqing branch of the Bank of China. He is currently employed by Fujian International Corporation Limited (福建省國際投資有限公司). He has been appointed as an independent non-executive Director since May 2001. Save as disclosed above, Mr. Pan did not hold any directorship in any public listed companies in the last three years and he does not hold any position in the Group.

There is no service agreement entered into between the Company and Mr. Pan. Mr. Pan is not appointed for a specific term but is subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Articles. Mr. Pan is entitled to an annual remuneration of HK\$10,000 which is determined based on the prevailing market rate, without any bonus payment.

As at the Latest Practicable Date, Mr. Pan does not have any other interests in the Shares, underlying Shares and debentures of the Company within the meaning of Part XV of the SFO and he does not have any relationship with any Directors, senior management or substantial or controlling Shareholders.

### **Mr. Cheung Chuen**

Mr. Cheung Chuen (張全), aged 33, is an independent non-executive director and a member of audit committee of the Company. He is a certified public accountant practicing in the United States of America and Hong Kong. Mr. Cheung graduated from Hong Kong Shue Yan College (now known as Hong Kong Shue Yan University) in 1999 with majoring in accounting and obtained a master degree in professional accounting from the Hong Kong Polytechnic University in 2004. He is a member of the American Institute of Certified Public Accountants and an associate member of the Hong Kong Institute of Certified Public Accountants. Mr. Cheung has over the years gained extensive experience in accounting and auditing. He has been appointed independent non-executive Director since September 2004. Save as Mr. Cheung currently is an independent non-executive director of Broad Intelligence International Pharmaceutical Holdings Limited, a listed company in Hong Kong, he did not hold any directorship in any public listed companies in the last three years and he does not hold any position in the Group.

There is no service agreement entered into between the Company and Mr. Cheung. Mr. Cheung is not appointed for a specific term but is subject to retirement by rotation and re-election at the Company's annual general meeting in accordance with the Articles. As at the Latest Practicable Date, Mr. Cheung is entitled to an annual remuneration of HK\$45,000 which is determined based on the prevailing market rate, without any bonus payment.

As at the Latest Practicable Date, Mr. Cheung does not have any other interests in the Shares, underlying Shares and debentures of the Company within the meaning of Part XV of the SFO and he does not have any relationship with any Directors, senior management or substantial or controlling Shareholders.

*In relation to ordinary resolution number 3 regarding the re-election of retiring Directors, Mr. Hu Zhao Rui and Mr. Lin Wan Xin shall retire as Director at the AGM pursuant to article 86(3) of the Articles and, being eligible, will offer themselves for re-election.*

### **Mr. Hu Zhao Rui**

Mr. Hu Zhao Rui (胡兆瑞), aged 50, is an executive director of the Company. Mr. Hu is a director of Fujian Fuqiang Delicate Circuit Plate Co., Ltd. ("Fuqiang"), a subsidiary of the Company. Mr. Hu is responsible for the daily financial management of the Company. He

graduated from Fuzhou Technical Institute (福州工業學校), majoring in finance and is certified public accountant in the PRC. Prior to joining the Company and its group companies in June 1998, he worked as the financial manager of several companies including Fujian Minjiang Shipping Company (福建省閩江航運總公司) and Fujian Fuqing Rongqiao Wharf Co., Ltd. (福建福清融僑碼頭港務有限公司), Fujiang Mingjiang Wu Yi Cement Transportation Company Limited (福建閩江武夷散裝水泥聯運公司) and Fujiang Hong Feng Investment & Development Company Limited (福建鴻豐投資發展有限公司). Mr. Hu has gained more than 21 years' experience in accounting and financial management. Save as disclosed above, Mr. Hu did not hold any directorship in any public listed companies in the last three years and he does not hold any position in the Group.

Mr. Hu has entered into a service agreement dated 29 December 2006 with the Company for a term of three years commencing from 1 January 2007, with a fixed term of one year, which shall be terminated if either party giving not less than six months' notice in writing to the other after the expiration of the said fixed term of one year. As at the Latest Practicable Date, Mr. Hu is entitled to a monthly salary of HK\$20,000 which is determined on the prevailing market rate and a year-end bonus to be determined by the Board with reference to the Company's performance and profitability.

As at the Latest Practicable Date, Mr. Hu has 1,000,000 underlying Shares attached to the share options granted by the Company. Save as disclosed above, Mr. Hu does not have any other interests in the Shares, underlying Shares and debentures of the Company within the meaning of Part XV of the SFO and he does not have any relationship with any Directors, senior management or substantial or controlling Shareholders.

### **Mr. Lin Wan Xin**

Mr. Lin Wan Xin (林萬新), aged 53, is an executive director of the Company. Mr. Lin is also the chairman and executive president of Fuqiang. He graduated from Fujian Teachers University (福建師範大學) and has gained extensive administration experience as the production director, administration director and vice-president of the general administration department of Fujian Teachers University (福建師範大學). Mr. Lin is currently a member of the 11th and 12th Political Consultative Standing Committee of Fuqing City in Fujian Province and a council member of the Printed Circuit Industry Association respectively. He joined the Group in March 1998 and was one of the founding members. Save as disclosed above, Mr. Lin did not hold any directorship in any public listed companies in the last three years and he does not hold any position in the Group.

Mr. Lin has entered into a service agreement dated 24 October 2007 with the Company for a term of three years commencing from 24 October 2007, with a fixed term of one year, which shall be terminated if either party giving not less than six months' notice in writing to the other after the expiration of the said fixed term of one year. As at the Latest Practicable Date, Mr. Lin is entitled to a monthly salary of HK\$20,000 which is determined on the prevailing market rate and a year-end bonus to be determined by the Board with reference to the Company's performance and profitability.

As at the Latest Practicable Date, Mr. Lin has 1,000,000 underlying Shares attached to the share options granted by the Company. Save as disclosed above, Mr. Lin does not have any other interests in the Shares, underlying Shares and debentures of the Company within the meaning of Part XV of the SFO. Save as Mr. Lin is a cousin of Mr. Lin Wan Qaing, an executive Director, he does not have any relationship with any Directors, senior management or substantial or controlling Shareholders.

Saved as disclosed above, there are no other matters in relation to the re-election of Mr. Xiang Song, Mr. Pan Chang Chi, Mr. Cheung Chuen, Mr. Hu Zhao Rui and Mr. Lin Wan Xin that need to be brought to the attention of the Stock Exchange or the Shareholders. There is no information relating to all the retiring Directors that is required to be disclosed pursuant to Rules 13.51(2)(h)–(v) of the Listing Rules.

### **6. ANNUAL GENERAL MEETING**

The notice of the AGM is set out on pages 13 to 16 of this circular. At the AGM, resolutions will be proposed to approve, inter alia, the granting of the Repurchase Mandate and Issue Mandate and the extension of the Issue Mandate by the addition thereto of the number of Shares repurchased pursuant to the Repurchase Mandate and the re-election of retiring Directors.

A form of proxy for use at the AGM is enclosed with this circular and such form of proxy is also published on the website of the Stock Exchange ([www.hkex.com.hk](http://www.hkex.com.hk)). In order to be valid, the form of proxy must be completed and signed in accordance with the instructions printed thereon and deposited at the Company's Hong Kong branch share registrar and transfer office, Hong Kong Registrars Limited of Shops 1712–1716, 17/F., Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, together with a power of attorney or other authority, if any, under which it is signed or a certified copy of such power or authority, not less than 48 hours before the time appointed for holding the meeting or adjourned meeting. The completion and return of the form of proxy will not preclude any Shareholder from attending and voting at the meeting if so wished.

### **7. PROCEDURES BY WHICH A POLL MAY BE DEMANDED**

Pursuant to article 66 of the Articles, a resolution put to the vote of a general meeting shall be decided on a show of hands unless (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) a poll is duly demanded or otherwise required under the Listing Rules. A poll may be demanded:

- (a) by the chairman of such meeting; or
- (b) by at least three Shareholders present in person or in the case of a Shareholder being a corporation by its duly authorised representative or by proxy for the time being entitled to vote at the meeting; or
- (c) by any Shareholder(s) present in person or in the case of a Shareholder being a corporation by its duly authorised representative or by proxy and representing not less than one-tenth of the total voting rights of all Shareholders having the right to vote at the meeting; or

- (d) by any Shareholder(s) present in person or in the case of a Shareholder being a corporation by its duly authorised representative or by proxy and holding Shares in the Company conferring a right to vote at the meeting being Shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all Shares conferring that right; or
- (e) if required by the rules of Designated Stock Exchange, by any Director or Directors who, individually or collectively, hold proxies in respect of Shares representing five per cent. or more of the total voting rights of all Shareholders having a right to vote at the meeting.

Pursuant to article 72 of the Articles, a Shareholder entitled to more than one vote on a poll need not use all his votes or cast all the votes he uses in the same way.

### 8. RESPONSIBILITY STATEMENT

This circular includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. The Directors collectively and individually accept full responsibility for the accuracy of the information contained in this circular and confirm, having made all reasonable enquiries, that to the best of their knowledge and belief there are no other facts the omission of which would make any statement herein misleading.

### 9. RECOMMENDATION

The Directors consider that the Repurchase Mandate, the Issue Mandate, the extension of the Issue Mandate and the re-election of the retiring Directors are in the best interests of the Company and the Shareholders. The Directors therefore recommend the Shareholders to vote in favour of the relevant resolutions as set out in the notice of the AGM on pages 13 to 16 of this circular.

### 10. GENERAL INFORMATION

# **EXPLANATORY STATEMENT OF THE SHARE REPURCHASE MANDATE**

---

The following explanatory statement contains all the information required pursuant to Rule 10.06 of the Listing Rules to be given to all Shareholders relating to a resolution to be proposed at the forthcoming AGM authorising the Repurchase Mandate.

## **1. EXERCISE OF THE REPURCHASE MANDATE**

Exercise in full of the Repurchase Mandate, on the basis of 558,169,000 Shares in issue as at the Latest Practicable Date and no further Shares are issued or repurchased prior to the AGM, could accordingly result in up to 55,816,900 Shares being repurchased by the Company during the period ending on the earliest of (i) the date of the next annual general meeting of the Company, (ii) the date by which the next annual general meeting of the Company is required by the articles of association of the Company or any applicable laws of the Cayman Islands to be held, or (iii) the date upon which such authority is revoked or varied by an ordinary resolution of the Shareholders in a general meeting of the Company.

## **2. REASONS FOR REPURCHASE**

The Directors have no present intention to repurchase any Shares but consider that the repurchase mandate will provide the Company the flexibility to make such repurchase when appropriate and beneficial to the Company and the Shareholders as a whole. Such repurchase may enhance the net assets value per Share and/or earnings per Share.

## **3. FUNDING OF REPURCHASE**

Repurchases must be made out of the funds legally available for the purpose in accordance with the memorandum and articles of association of the Company and the applicable laws and regulations of the Cayman Islands and the Listing Rules. The Companies Law Cap. 22 of the Cayman Islands (the “Laws”) provide that a share repurchase by the Company may only be made out of profits of the Company or out of the proceeds of a fresh issue of Shares made for the purpose or, if so authorised by the Articles and subject to the provisions of the Laws, out of capital. Any premium payable on a repurchase over the par value of the shares repurchased must be provided for out of profits of the Company or out of the Company’s Share premium account or, if so authorised by the Articles and subject to the provisions of the Laws, out of capital.

Taking into account, as compared with the financial position of the Company as at 30 June 2007 (being the date of its latest published audited financial statements), the Directors consider that there would be a material adverse impact on the working capital and on the gearing position of the Company in the event that the proposed Repurchase Mandate were to be exercised in full during the proposed repurchase period. However, the Directors confirm that none of them have any intention to make any repurchase would be made in circumstances that would have a material adverse impact on the working capital or gearing position of the Company from time to time appropriate.

### **4. DIRECTORS, THEIR ASSOCIATES AND CONNECTED PERSONS**

None of the Directors nor any of their associates (as defined in the Listing Rules), to the best of the knowledge and belief of the Directors having made all reasonable enquiries, has any present intention to sell Shares to the Company in the event that the Repurchase Mandate is approved by Shareholders.

No connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she neither has a present intention to sell any Shares to the Company nor has he/she undertaken not to do so in the event that the Company is authorised to make repurchases of Shares.

### **5. UNDERTAKING OF THE DIRECTORS**

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make purchases pursuant to the Repurchase Mandate in accordance with the Listing Rules and all applicable laws of the Cayman Islands, and in accordance with the regulations set out in the memorandum and articles of association of the Company.

### **6. EFFECT OF TAKEOVERS CODE**

If on exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of Rule 32 of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert could, depending on the level of increase of Shareholders' interest, obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. The Directors are not aware of any Shareholders, or a group of Shareholders acting in concert, who may become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code in the event that the Directors exercise the power to repurchase Shares pursuant to the Repurchase Mandate.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Company, Mr. Lin Wan Qaing, an executive Director who held approximately 40.90% of the issued share capital of the Company, was the substantial Shareholder holding more than 10% of the issued share capital of the Company. In the event that the Directors should exercise in full the powers to repurchase Shares pursuant to the Repurchase Mandate, the shareholding of Mr. Lin Wan Qaing in the Company would be increased to approximately 45.44% of the issued share capital of the Company. Such an increase would give rise to an obligation to make a mandatory offer under Rules 26 to 32 of the Takeovers Code. In any event, the Directors do not intend to exercise the Repurchase Mandate to an extent which will trigger off the mandatory offer requirement pursuant to the rules of the Takeovers Code or which will reduce the aggregate amount of the share capital of the Company in public hands to below 25%.
