AND THAT I do not intend to object to the bankrupts' discharge.

AND THAT the bankrupts' creditors have the right to object to their discharge on any of the following grounds-

- (i) in the case of a discharge to which section 30A(2)(a) of the Bankruptcy Ordinance (Chapter 6) applies, that the bankrupt is likely within 5 years of the commencement of the bankruptcy to be able to make a significant contribution to his[her] estate;
- (ii) that the discharge of the bankrupt would prejudice the administration of his[her] estate;
- (iii) that the bankrupt has failed to co-operate in the administration of his[her] estate;
- (iv) that the conduct of the bankrupt, either in respect of the period before or the period after the commencement of

- (v) the bankruptcy, has been unsatisfactory; without limiting section 30A(4)(c) or (d) of the Bankruptcy Ordinance (Chapter 6)(i.e. ground (iii) or (iv)), that the bankrupt has departed from Hong Kong and has failed forthwith to return to Hong Kong following a request to do so from the trustee;
- (vi) that the bankrupt has continued to trade after knowing himself/herself to be insolvent;
- (vii) that the bankrupt has committed an offence under section 129 or any of sections 131 to 136 of the Bankruptcy Ordinance (Chapter 6);
- (viii) that the bankrupt has failed to prepare an annual report of his/her earnings and acquisitions for the trustee. (*Note: As old bankrupts are under no statutory duty to prepare and submit any annual report, any objection based on this ground may not be accepted by the court as a valid ground.*)
